Rental Policy and Agreement

- Rental equipment is available for checkout. A valid ID is required. Renters must be 18 years of age in order to rent equipment from the ORC.
- Payment and any repair/replacement fees for equipment will be charged and must be paid at time of equipment check-in.
- Equipment will be inspected upon check-out and check-in.
- The renter will be charged for damaged equipment at the cost fixing or replacing the item.
- The renter will be charged a \$15 per disc that is not returned or for a disc that is damaged.
- There is limited quantity of equipment available. Equipment is rented on a first-come, first serve basis.
- Equipment rented late will be charged an additional \$5.00 per day.



I agree that I am solely responsible for the return of this equipment and its condition upon return. If for whatever reason, I do not return this equipment, I agree to reimburse the Ottawa Recreation Commission the full amount necessary for replacement (\$45). Further, I understand that I will also be asked to pay any required repair cost, due to my negligence or improper use of this equipment. I understand that these fees are due at the time of check-in.

As a condition precedent to the issuance of a rental permit for the use of Ottawa Recreation Commission equipment, I, the undersigned, agree to the following terms and conditions and assume the responsibility to ensure that my attendees, guests, and I abide by all rules and regulations governing the use of the equipment. It is understood that the City of Ottawa, Kansas, USD 290 and Ottawa Recreation Commission, its officers, employees and officials will not be responsible for accidents, injuries, illness, or loss of group or individual property relating to the use of Ottawa Recreation Commission equipment. I agree to identify and hold harmless the City of Ottawa, Kansas, USD 290 and Ottawa Recreation Commission, its officers, employees and officials against and from liability whatsoever arising from the use of Ottawa Recreation Commission equipment by attendees, guests and/or myself.
